COLD WEATHER PREPARATIONS

With cold weather on us, livestock management becomes even more crucial. Supplemental sources of energy may become necessary in lactating animals to maintain body condition scores along with ensuring the proper amount of forage is available. Hav resources need to be monitored closely.

Feeding hay during the winter offers its own set of challenges. Mud becomes an issue in high traffic areas and can become an issue to cows calving during this time of year. Moving hay feeders or creating heavy use areas can minimize mud and keep calves from becoming trapped or losing core body heat.

During these cold dreary days is a great time to evaluate your pasture renovation strategies and determine what if anything needs to be done to improve them for summer and fall grazing. Pulling soil tests now may also allow you to get results in a more timely manner and be better prepared for spring fertilizer applications.

TAEP Approvals and Deadlines



If you applied for the AGRICULTURAL Tennessee ENHANCEMENT Enhancement Program, you should have received a letter during the month of

December stating your approval status. For those applying for livestock equipment, the reimbursement instructions were also mailed in December. For all other program areas, the reimbursement instructions are slated to be mailed sometime this month.

The reimbursement deadlines for this year's program is April 1st for livestock equipment and September 1st for all other categories. Please note that you must follow all instructions in the packet for reimbursement. DICAMBA USE REQUIREMENTS

The TN

Department Agriculture is taking measures to mitigate the risk of drift of herbicides containing dicamba. In accordance with new rules filed with the Secretary of State:

Anyone applying dicamba products must be certified as a private applicator or licensed as a pest control operator in the category of Agricultural Pest Control (AGE) and is required to keep records for such applications.

- The use of older formulations of dicamba products for the remainder of this agricultural SMALL ORCHARD SHORT COURSE TO BE OFFERED growing season is prohibited.
- To minimize the potential for off-target movement of the product due to temperature inversion, dicamba may only be applied from 9:00 a.m. to 4:00 p.m. in the respective time zone for the location of application.
- Applying dicamba over the top of cotton after first bloom is prohibited.

This action is in response to primarily farmer to farmer complaints currently under investigation by TDA of suspected dicamba related damage on recommendations of UT Extension and only apply to dicamba products purchased and used immediately through October 1.

"Our approach will offer protection to those who stand to be negatively impacted by off-target movement of dicamba while also allowing those farmers who have invested in products designed for their crops to continue to use the appropriate homas Greenlee herbicides responsibly," Agriculture Commissioner Jai Templeton said.

Dicamba is a broad-spectrum herbicide. Products containing dicamba have been used for household

State and federal laws mandate applicators bulls to sale and more information, you may contact the strictly follow label directions and consider the weather and potential for temperature inversions when applying any herbicide. Any suspected misapplication should be reported immediately to TDA at 1-800-628-2631 or 615-837-5148. The department will take appropriate enforcement action for any misapplication, including but not limited to suspension or revocation of a certificate and state penalties up to \$1,500 per violation, in addition to federal penalties and possible criminal prosecution.
